By permit issuance through the State of Texas, Wildlife Management at Hilltop Lakes is authorized only in association with the Texas Parks and Wildlife Department Managed Lands Deer Program. The TPWD MLDP procedures require that permits can only be issued to the Designated Common Ground at Hilltop Lakes. Privately owned lots at Hilltop Lakes may be included in Wildlife Management when the landowner signs the Managed Ground Release (this form) requesting that the landowner's private property be included as Designated Managed Ground for the purpose of Wildlife Management only.

By signing, the Managed Ground Release, the landowner gives permission to add the landowner's private property to the Designated Common Ground Map and requests that Wildlife Management take

place on the private property belonging to the landowner. This does not add the landowner's property to the "Common Ground Pool" of locations that are given out to other members per the by-laws.

By signing, the landowner gives permission for the Board Members of the Hilltop Lakes Wildlife Management Team to have ingress and egress onto their property for the purposes of inspecting and verification of compliance to all By-Laws, Rules, and Directives.

By signing, the landowner releases the Hilltop Lakes Wildlife Management Team and their Board of Directors, past, present, or future, from all liabilities.

By signing, I acknowledge that I have received instruction and I understand the procedures involved in tagging and documenting of my animal harvests.

By signing, the landowner acknowledges that they have received, understand, and will be held accountable for following the Hilltop Lakes Wildlife Management Team's By-Laws, Rules, and Directives.

By signing, this form I certify that I am owner of the property listed above and that I am asking to include my private property to be included under the TPWD MLDP for management purposes.

By signing, I understand that all members of the WMT must be in good standing with the Hilltop Lakes Property Owners Association (HTLPOA) and cannot be more than 90 days delinquent with the HTLPOA. I understand this standing will be verified by a WMT board member in September and January of the current MLD deer season or the member can provide proof of good standing themselves via a document from the HTLPOA in September and January of the current MLD deer season. Members that are not in good standing at these times will be ineligible to hunt and their keys will be disabled from accessing the MLD issued tags until proof of good standing with the HTLPOA is shown.
